This is the Privacy Policy ("Privacy Policy") of Cloud Provider USA, LLC ("CPU" or "us" or "we"). CPU is committed to maintaining privacy protections for its users. Our Privacy Policy was developed as an extension of our commitment to combine quality infrastructure services (the "Service") with integrity in dealing with our users and customers. The Privacy Policy is designed to assist you in understanding how we collect, use and store the personal information you provide to us. Our Master Service Agreement, which incorporates by reference this Privacy Policy, governs your use of our online services, any content or information therein, the CPU website at <a href="https://www.cloudproviderusa.com">www.cloudproviderusa.com</a>, any subdomains of cloudproviderusa.com, and any other website pages on which services are provided by us (collectively, the "Site").

### **Information We Collect**

We collect "Non-Personal Information" and "Personal Information." Non-Personal Information includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. Personal Information includes information that can be linked to a specific individual, such as a name, address, telephone number, email address, payment information and other information that you submit to us at the Site. Sharing Personal Information with us is entirely optional.

In an effort to improve the quality of the Site and the Service, we track information provided to us by your browser when you view the Site or use the Service, such as your Internet service provider, the website you came from (known as the "referring URL"), the type of browser you use, your operating system, the device from which you connected to the Service, the time and date of access, the Site pages viewed, time spent at our Site, the sites visited just before and just after our Site, and other information that does not personally identify you. This makes it easier for a user to move from site to site and to complete transactions over the Internet. Cookies should make your online experience easier and more personalized.

Cookies are sent to a user's browser from our servers and are stored on the user's computer hard drive. Sending a cookie to a user's browser enables us to collect Non-Personal information about that user and keep a record of the user's preferences when utilizing our services, both on an individual and aggregate basis.

CPU may use both persistent and session cookies; persistent cookies remain on your computer after you close your session and until you delete them, while session cookies expire when you close your browser.

Most Internet browsers automatically accept cookies, but if you do not want your information to be collected through the use of cookies, you can change the settings on your browser to stop accepting cookies or to prompt you before accepting a cookie from the websites you visit. However, please be aware that some features of the Service may not function properly if you disable cookies. The Site does not currently recognize browser 'Do Not Track' signals.

In addition to the information provided automatically by your browser when you visit the Site, you may choose to provide www.cloudproviderusa.com

us with personally identifiable information, such as your email address, name, payment information and postal address. To use elements of the Service a personal profile will be created for you. By registering, you are authorizing us to collect, store and use your email address in accordance with this Privacy Policy.
